RISK STATEMENT

Sailing is by its nature an unpredictable sport and therefore involves an element of risk. By taking part in the event, each participant agrees and acknowledges that:

- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e) The provision of safety cover does not relieve them of their own responsibilities;
- f) The provision of a safety boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- g) A decision by the organisers to give participants permission to launch their boats and to sail does not imply that the sailing conditions are necessarily safe for all participants to do so;
- h) The decision as to the suitability of the conditions and whether to launch and sail is the responsibility of each participant if over the age of 18 or of the parent/guardian if the participant is under the age of 18.

PARENT/GUARDIAN DECLARATION

This form is required for all participants under 18 years of age. It must be signed by the parent/guardian of the younger person and NOT their representative.
